

Mighty Lift Warranty (End User Version)

Mighty Lift warrants our electric products (pallet jacks, stackers, scissor lift, etc) to be free from defective in material and workmanship in accordance with the terms and conditions stated below.

WHAT IS WARRANTED

One (1) Year or 2000 usage hours, whichever occurs first, parts only warranty, following the date of delivery to the first purchaser and covers all components subject to the limitations and exclusions listed below: motors (except brushes), hydraulic pump, hydraulic pump motor, hydraulic valves, electronic components (except contact tips), control card, truck frame, mast, steel frame, fork, castings and drive unit.

Ninety (90) Day all other parts warranty. The parts covered also include those listed in the above warranty.

Ninety (90) day warranty items include, but not limited to battery, battery charger, wheels & bearing, brakes, etc.

Any parts replaced pursuant to the warranty are warranted only for the balance of the warranty period.

WHAT IS NOT WARRANTED

1. Defects or damage resulting from accident, misuse, lack of recommended or reasonable maintenance, improper repairs or parts replacement, use for replacement parts not conforming to MIGHTY LIFT standards, unauthorized modifications, or neglect.
2. Routine replacement of consumable parts such as, but not limited to, light bulbs, belts, oils, motor brushes, contactor tips, switches, brake shoes and ignition parts.
3. Routine or recommended maintenance services such as, but not limited to, tune ups, cleaning, adjustments or lubrications.
4. Batteries, battery chargers, tires, wheel rims, masts and attachments not manufactured by MIGHTY LIFT that are subject to warranties of the manufacturers of those items.
5. Mighty Lift reserves the right to make ongoing changes in design and improvements to its product at any time without obligation to make such changes or improvements to its products previously manufactured.

SECURING WARRANTY SERVICE

To secure warranty service, the purchaser must (1) report the equipment defect to MIGHTY LIFT and request warranty parts within the applicable warranty term, (2) present evidence of the warranty start date (3) make the defective parts available for inspection by MIGHTY LIFT.

Warranty authorized by MIGHTY LIFT will be performed without charge to the purchaser for parts. Mighty Lift's liability for damages for breach of this Warranty shall not exceed the amount of the purchase price of the product or part in respect of which such damages are claimed. **IN NO EVENT SHALL MIGHTY LIFT BE LIABLE FOR INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES OR FOR LOSS OF PROFIT OR DAMAGE TO TRADE OR BUSINESS FOR BREACH OF THIS WARRANTY.**
